The Director's report. Rod Stroman announced that the NSSA was proposing increasing shoot fees to .04 per target. This will be voted on at the upcoming meeting of the EC.

### **New Business**

Mid Carolina Gun Club proposed holding the 2013 State Championships at that club on August 23-25, 20123. Bonnie Gill moved to accept this proposal. The motion was seconded and **passed**.

There was discussion on the appropriateness of continuing the State policy of restricting the State Shoot to clubs having five or more skeet fields. Without action, it was recommended that Greenville provide a procedure for accommodating our projected number of shooters with only four fields. Such proposal to be presented to the EC at their Spring meeting.

Rick Willey led a discussion of awards for Junior and Sub Junior shooters. He moved that:

1. Junior and Sub Junior concurrent winners in the HOA event at the State Shoot be presented the same awards as are presented to major event winners.
2. Junior and Sub Junior concurrent selectees for the State Team be allowed to purchase a buckle similar to the one awarded to the Top Ten. This provision to be retroactive to include the 2012 Team.

Item two above was amended to include all concurrents. The motion was seconded and, after discussion, **passed**.
