

Minutes of the 2013 Annual Meeting - South Carolina Skeet Shooting Association

The annual meeting of the SCSSA was called to order by Mike Malone, Friday evening, August 23, 2013 at Mid Carolina Gun Club. Vice President, Jim Gill was excused. All other officers were present.

The minutes of the 2012 meeting were presented and **approved**.

The Treasurer's report was given by Stan Salter. It was **approved**.

David Reeves invited the association to hold the 2014 State Championships at the Greenville Gun Club. After considerable discussion, Brad Ludwig moved that we waive the requirement for five fields to hold the shoot, such waiver good for one year. The motion was seconded and **passed**. Eldon Carson then moved to hold the 2014 championships at Greenville. The motion was seconded and **passed**. Discussion ensued on how to accommodate our volume of shooting at Greenville. Robert Lindley moved that we hold the championship as a closed shoot. The motion was seconded but **failed**. Discussion ended with consensus that we will hold a four rotation shoot at Greenville.

The Director's report: Rod Stroman announced that the NSSA rules would change to prohibit referees from using entertainment devices with "ear buds" during competition. A Military Veteran concurrent will be added and the time allowed on station before calling for a target will change from 15 seconds to 10 seconds.

The Hall of Fame Committee announced the selection of Mike Malone for inclusion in the Hall of Fame. Eldon Carson recounted the accomplishments of Malone leading to his selection.
