## **2019 Annual Meeting Minutes**

The annual meeting of the SCSSA was called to order by Benji Turner, Saturday evening, 24 August, 2019, at 2005, at Mid-Carolina Gun Club.

The minutes of the 2018 meeting were presented and approved. Randy King made motion to accept and Kevin Suitt seconded.

### **Report of Committees:**

The Association president discussed general info about the shoot, including All-American and Krieghoff teams.

The vice president announced the state teams. Also, spoke about committees. Hall of Fame committee, criteria for nomination, and that the criteria for the Hall of Fame are to be based on the shooting accomplishments within the state.

The treasurer's report was given. Randy King made motion to accept and Brad Ludwig seconded.

Directors report was given on the I zone shoot by Randy King

### **Report of Committees:**

Hall of Fame committee members were announced.... Randy King, Kevin Suitt, Dave Reeves

Hall of Fame nominating committee members are Terry Ridenhour and Marla Tupper

Bernie Till discussed the youth program in South Carolina. Stated it was the largest program in the Southeast with a 30% growth. 300 youths shoot to qualify for 120 slots. Thanked us for waiving fees for youth shooters. Also thanked competitors for setting a good example.

### **Bylaws:**

Vice president discussed bylaws. Specifically, the need to add a section on awards so that we can provide Hall of Fame/honor roll recipients awards in the future.

### **Unfinished Business:**

Discussion about having the I zone at Greenville. No progress was made, no further discussion.

**Elections:**

The nominating committee nominated Mark Blankenship for Vice President. Frank Suber made a motion to accept the nomination, and Kevin Suitt seconded. Mark Blankenship was elected unanimously.

**Annual Shoot:**

Greenville is in line for the next 8 shoot. Discussion on a four-day shoot or three-day shoot was conducted. Discussion about the numbers able to shoot on a four-day or three-day shoot was made. Dave Reeves made a motion to accept a four-day shoot, Bert Ingram seconded. Vote was taken with the results of 8 yeas and 19 nays. Motion was defeated. Brad Ludwig made a motion to approve a three-day shoot with Frank Suber seconding. Vote was taken with the results of 26 yeas and 0 nays. A three-day shoot was approved. Discussion followed on a September or August shoot and whether to leave it as the same weekend next year. Discussion was also made about holding a junior shoot. Unanimous consensus was to leave it up to the club.

**New Business:**

Discussion was made concerning state membership fees being done away with. Proposal was made to do away with the state membership fees in exchange for a one penny increase in state target fees. In addition, life members would get a 5 dollar per gun discount at the state shoot. Randy King made a motion to accept, Brad Ludwig seconded. Vote was taken with the result being 17 yeas and 0 nays.

**Motion was made to adjourn the meeting at 2055 by Randy King and seconded by Jacob Turner.**
